3:30pm-5:30pm Constituency Meeting Block 2: Strategic Budgeting for Sustainability

As our orchestras navigate rising costs and uncertain revenue streams, smart and nimble financial planning is more important than ever. This session will explore how orchestras can identify the income and expense levers within their control, be alert to outside influences beyond their



control, build robust multi-year financial plans, and proactively address the cost structures required to sustain current operations. Drawing on nonprofit forecasting and budgeting strategies, we'll dive into practical approaches for incorporating contingency planning to support organizational stability in a shifting financial landscape. Whether you're preparing for the next fiscal year or thinking longer-term, this session offers actionable insights to help you plan for a sustainable and resilient future.

We are honored to have **Faith Raiguel** lead this session. With a distinguished career that includes her tenure as Chief Financial Officer of the **LA Opera**, Faith brings deep expertise in nonprofit financial strategy, planning, and sustainability. She is a long-standing faculty member of the League's **Essentials of Orchestra Management** program, is currently Treasurer of the Board of Directors for the **Silk Road Ensemble**, and formerly served on the board of **Street Symphony**.

Stay informed on the federal policy issues that matter most to orchestras. In this timely session, **Heather Noonan**, the League's Vice President for Advocacy, will share the latest developments from Capitol Hill and federal agencies—covering topics such as arts funding, tax policy, education, visa processing for international artists, and nonprofit workforce legislation. Attendees will gain insight into how these policies may impact orchestras of all sizes and learn how to engage effectively in advocacy efforts at the local and national levels. Bring your questions and join the conversation on how public policy continues to shape the future of our field.

10.45am-11:45am Maximizing Board Engagement: Strategies for Accountability, Participation, and Fundraising

Board engagement is an ongoing challenge—and opportunity—for orchestras of all sizes. For medium-budget orchestras in particular, building a strong, active board can significantly influence organizational sustainability. This session explores practical strategies for deepening board involvement, from fostering a culture of accountability to navigating difficult conversations when expectations aren't being met. As other sources of contributed income face increasing uncertainty, board fundraising has become more essential than ever. Learn how to reengage disengaged members, promote meaningful participation, and



equip your board to confidently support fundraising efforts. Drawing on examples from organizations with strong board performance, this session offers fresh approaches to strengthening board relationships and maximizing their impact on your orchestra's future.

We are delighted to welcome back **David Styers** to lead this session, following his highly successful presentation on orchestra governance at Midwinter 2024. David is Director of Learning and Leadership Programs at the League of American Orchestras and a longtime Senior Governance Consultant with BoardSource, with over three decades of experience in nonprofit governance, board strategy, and cross-sector leadership training.
