	Maurice Abravanel Hall is an architectural and artistic icon in the heart of downtown Salt Lake City. Built as the home of the Utah Symphony in 1979, the hall was designed by FFKR Architects in collaboration with noted acoustician Cyril M. Harris. It is named for Maurice Abravanel, the organization's music director from 1947-1979 and champion of classical music throughout Utah. The hall is renowned for its acoustical excellence, distinctive architecture, and a stunning four-story glass lobby boasting iconic city views and a red blown-glass sculpture by renowned glass artist Dale Chihuly that was part of the 2002 Olympic Arts Festival.
