1:00pm-2:30pm Constituency Meeting Block 1: Demystifying the Magic on the Podium

Join conductor Robert Moody, Music Director of the Baltimore Chamber Orchestra and the Memphis Symphony, and a string quartet to learn insights into what conductors actually do on the podium, how they influence musicians to bring their best to each performance and how they navigate change during a performance. These skills can be applied to your work as a board member as you navigate working with orchestra leaders, staff, and musicians.

“I’ve come to see my role on the podium as more than just a conductor—it’s about creating space for empathy and connection. As Robert Fulghum once wrote, sometimes what people need isn’t a leader, but a minister or a counselor. I can’t be all things to everyone, but I can foster an environment where trust, breath, and musical sensitivity guide us. When we’re truly open to each other—musicians, soloists, conductor—that’s when we find the next level of music-making. That’s where the magic lives.” -Robert Moody

11:15am-12:45pm Constituency Meeting Block 3: League Board Chair, Alan Mason, in conversation with Ann Meier Baker

Alan Mason will conduct an engaging conversation with Ann Meier Baker to learn from her decades perspective on arts organizations and board governance. Ann was the director of Music and Opera at the National Endowment for the Arts from January 2015 until May 2025. She oversaw the NEA's grantmaking in music and opera, directed the NEA Jazz Masters Fellowships, and served on the senior leadership team for the NEA's Sound Health Network. Previously, Baker spent 15 years as president and CEO of Chorus America, where she led the national membership association of more than 2,000 professional, volunteer, symphonic, and children/youth choruses. She was also the founding director of the National School Boards Association Foundation, an incubator for new ideas about the challenges facing urban school board leaders and other issues in public education. In addition, Baker held leadership roles at the League of American Orchestras and the National Association for Music Education, and she began her career as a professional singer with the United States Air Force Singing Sergeants.
